4 ~~—— A. "Blended learning program" means a program under the direction of an LEA:~~

5 ~~—— (1) where a student learns at least in part:~~

6 ~~—— (a) at a supervised brick and mortar location away from home; and~~

7 ~~—— (b) at least in part through an online delivery; and~~

8 ~~—— (2) that may include some element of student control over time, place, or path, or~~
9 ~~pace.~~

10 ~~—— B. "Board" means the Utah State Board of Education.~~

11 ~~—— C. "Distance learning program" means a program, under the direction of an LEA,~~
12 ~~in which the participants are a distance from each other in space.~~

13 ~~—— D. "Enrollment verification data" includes:~~

14 ~~—— (1) a student's birth certificate or other verification of age;~~

15 ~~—— (2) verification of immunization or exemption from immunization form;~~

16 ~~—— (3) proof of Utah public school residency;~~

17 ~~—— (4) family income verification; or~~

18 ~~—— (5) special education program information, including information for:~~

19 ~~—— (a) an individualized education program;~~

20 ~~—— (b) a Section 504 accommodation plan; and~~

21 ~~—— (c) an English learner plan.~~

22 ~~—— E. "Competency based learning program" means an education program that~~
23 ~~requires a student to acquire a competency and includes a classroom structure and~~
24 ~~operation that aid and facilitate the acquisition of specified competencies on an individual~~
25 ~~basis wherein a student is allowed to master and demonstrate competencies as fast as the~~
26 ~~student is able.~~

27 ~~—— F. "LEA" or "local education agency" means a school district or charter school.~~

28 ~~—— F. "Nontraditional Program" means a program within an LEA that consists of eligible,~~

- 1 enrolled public school students where the student receives instruction through a:
2 ——— (1) distance learning program;
3 ——— (2) online learning program;
4 ——— (3) blended learning program; or
5 ——— (4) competency based learning program.
6 ——— G. "Online learning program" means a program, under the direction of an LEA,
7 where there is an organized offering of courses delivered primarily over the internet.
8 ——— H. "Superintendent" means the State Superintendent of Public Instruction or the
9 Superintendent's designee.
10 ——— I. "Third party provider" means a third party who provides educational services on
11 behalf of an LEA.

12 **~~R277-418-2. Authority and Purpose.~~**

- 13 ——— A. This rule is authorized under Utah Constitution Article X, Section 3 which vests
14 general control and supervision over public education in the Board and by Subsection
15 53E-3-401(4) which allows the Board to adopt rules in accordance with its responsibilities.
16 ——— B. The purpose of this rule is to provide standards and procedures for nontraditional
17 programs.

- 20 ——— A. An LEA offering a nontraditional program shall comply with the following
21 standards:
22 ——— (1) student eligibility and membership/enrollment requirements described in
23 R277-419-5, 419-6, and 419-7;
24 ——— (2) school and program requirements described in R277-419-3(A);
25 ——— (3) minimum school day requirements described in R277-419-4(A)1-2;
26 ——— (4) compliance with official record standards and membership audit requirements

- 3 ~~—— (b) R277-419-4C and 4D;~~
- 4 ~~—— (5) educator licensure requirements described in R277-502;~~

- 22 ~~—— (1) develop a written monitoring plan to supervise the activities and services~~
23 ~~provided by the third party provider;~~
- 24 ~~—— (2) ensure the third party provider is complying with:~~
- 25 ~~—— (a) federal law;~~
- 26 ~~—— (b) state law; and~~
- 27 ~~—— (c) Board rules;~~
- 28 ~~—— (3) monitor and supervise all activities of the third party provider related to services~~

1 provided by the third party provider to the LEA; and
2 ~~—— (4) maintain documentation of the LEA's supervisory activities consistent with the~~
3 ~~LEA's administrative records retention schedule.~~
4 ~~—— C. An LEA shall:~~
5 ~~—— (1) verify the accuracy and validity of a student's enrollment verification data, prior~~
6 ~~to enrolling a student in the LEA; and~~
7 ~~—— (2) provide a student and the student's parent or guardian with notification of the~~
8 ~~student's enrollment in a school or program within the LEA.~~
9 ~~—— D. The Board or the Superintendent may require an LEA to repay public funds to~~
10 ~~the Superintendent if:~~
11 ~~—— (1) the LEA or the LEA's third party provider fails to comply with the provisions of~~
12 ~~this R277-418; and~~
13 ~~—— (2) the repayment is made in accordance with the procedures established in~~

15 ~~—— E. An LEA offering a nontraditional program shall retain sufficient documentation to~~
16 ~~demonstrate the nontraditional program's compliance with this R277-418-3.~~
